Diane to ask IEF about the grant for a counselor.
- Diane and Tasey created a code of conduct for athletes. Murdock would like to review it.
- Murdock hasn't heard anything about scheduling soccer. Basketball is in the gym after school.
- Khal asks about graduation volunteers. Val is keeping a master list for volunteers.
- Audio visual request for funding. Ben Coke has been used for past years. His company went out of business, but he works for this current new company that handled Rise Week and last year's graduation. The quote came in late, and we missed the WCSD deadline. Boosters did not fund last year's AV. It was not budgeted this year. WCSD pays for staging. The Vice Principal arranged AV last year. Tierney doesn't know who paid for it. Holly asks about using other budgeted accounts with remaining funds: Graduation, Assemblies, Class of 2023. Diane asks about Woody Woodruff as an AV company. He may offer a break for non-profits. Also, Mike Jansen may have a referral for AV as he's involved in worldwide event planning. Tierney offers to pick up graduation cakes under the Principals fund, if we contribute to AV. Tara asks the crab feed AV company. Diane helps Woody and Tierney to connect. UPDATE: From Principal Cahill's email on June 8th: she "piecemealed together enough \$ to pay for the audio-visual contract for graduation."

Lourdes and Samantha are working together. Lourdes asks to add another \$500 to the 2023/24 budget for the Hispanic Forum. Samantha speaks about Mi Cultura and the different cultures we have at the school. The goal is to bring awareness of each other's culture. Lourdes created a calendar of events to add the Hispanic Forum, social events, and Mi Cultura. She's looking for a student to continue Mi Cultura. Lourdes is leading the charge, and we have a budget. She plans to receive 15% back through concessions, etc. Holly reminds the Board that the new budget should be approved by July 1, the start of the new fiscal year.

TREASURER REPORT (Alyssa): Alyssa emailed her Treasurer report on 6/4/23 the FY2023 Budget vs. Actuals.

- We paid for Leadership dances at \$1500 for Prom, the full budget. Junior class has over \$10,000 in ticket sales. Alyssa suggests the Junior class reimburse Boosters for our Prom contributions. Amee agrees that reimbursement is appropriate. Amee will talk to Mr. Sombrano. Money through WCSD gets complicated. Amee needs an invoice for services to get reimbursed. Diane suggests the Junior class pay for Prom next year through their ticket sales.
